All travel arrangements made on behalf of the VOYAGEURS SKI CLUB (VSC) for the 2018/2019 Charter are provided by **The Vacation Station**.

PLEASE NOTE: All cheques are to be made payable to the 'THE VACATION STATION'. Payments must be by postdated cheque or pre-authorized credit card, provided at the time of sign-up. Trip cost and payment schedule is on page 2 of this agreement.

NSF cheques (or declined credit cards) are subject to a \$45.00 fee that must be paid by the participant prior to being reinstated to 'Member in Good Standing' status. All Trip payments must be made as per the payment schedule. Club credits cannot be used to cover penalties.

Cancellation Policy:

Participants must notify the Charter Trip Director of cancellation in writing, and the notice must be acknowledged by the Charter Trip Director. Individual participants may not arrange "substitutes".

The Insurance payment is non-refundable.

Cancellation penalties are:

- (A) Up to Nov. 1, 2018: without penalty
- (B) Nov. 2 to Dec. 21: \$400
- (C) Dec. 22 to Jan. 22: 50% of Tour Cost
- (D) Jan. 23 to Feb. 24: 100% of Tour Cost

Airfare portion may be subject to additional cancellation or change charges, payable by the participant.

Participants who 'No Show' (missing the Flights or Transfers), or are denied entry/travel for any reason, forfeit the total tour cost and are solely responsible for any additional costs that may be incurred.

There are no refunds or adjustments for any unused portion(s) of The Charter Trip package. The Club Directors at their sole discretion, may cancel, substitute or otherwise modify any component of this trip.
